1. CALL TO ORDER

Mr. Lang called the meeting to order at 6:02 p.m.

Mr. Warren administered the Oath of Office to Mr. Betserai for a three-year term expiring June 30, 2020.

A motion was made by Ms. Mortier and supported by Mr. Lang to approve Board Officer comprised of Mr. Lang as President, Ms. Mortier as Vice President, and Mr. Betserai as Secretary-Treasurer. The motion was approved unanimously.

2. ROLL CALL AND APPROVAL OF AGENDA

Roll call was taken.

A motion was made by Ms. Mortier and supported by Mr. Betserai to approve the agenda as amended to move Data Reports, Discussion Items, and Action Items to the top of the agenda due to time constraints. The motion was approved unanimously.

3. BOARD COMMENTS

There were no Board comments.

4. DISCUSSION ITEMS

a. Board Candidate Interview

The Board was introduced to Ms. Boruta, who shared more about her background, interest, and experience in charter schools and education as a Teach for America teacher and former board member of a charter school. Mr. Betserai spoke highly of her, having known her from previous employment.

b. GVSU Charter Contract Amendment

Mr. McAnally reviewed the GVSU Charter Contract Amendment as requested by GVSU, explaining the amendment does not affect Canton Prep.

c. 2016-17 Board Funds Rollover and 2017-18 Board Funds Budget

The Board reviewed the 2016-17 Board Funds Rollover, and reviewed and discussed the proposed 2017-18 Board Funds Budget as presented by the school leadership team.

5. ACTION ITEMS

a. Approval of the June 21, 2017 Board Meeting Minutes

A motion was made by Ms. Mortier and supported by Mr. Betserai to approve the June 21, 2017 Board Meeting Minutes as presented. The motion was approved unanimously.

b. Approval of the 2016-17 Board Funds Rollover and 2017-18 Board Funds Budget

A motion was made by Ms. Mortier and supported by Mr. Betserai to approve the 2016-17 Board Funds Rollover of \$2,000 (5004BR0916002) and 2017-18 Board Funds Budget of \$37,000 as presented. The motion was approved unanimously.

c. Nomination of Board Candidate for Appointment

A motion was made by Mr. Betserai and supported by Ms. Mortier to nominate Mary Jo Boruta for Board appointment. The motion was approved unanimously.

d. Charter Contract Amendment Resolution

A motion was made by Ms. Mortier and supported by Mr. Betserai to approve the Charter Contract Amendment Resolution as presented. The motion was approved unanimously.

6. MANAGEMENT REPORTS

a. School Leadership Report

Ms. Roberts welcomed everyone back for the start of the 2017-18 school year. She provided positive feedback on the inaugural Charger Camp that took place for incoming 9<sup>th</sup> graders.

Mr. Batt reviewed enrollment, stating the attrition and no-show rate was much lower this year. Mr. Angerer answered a question from the Board about the school budget.

Ms. Roberts highlighted upcoming events, particularly Step-Up Days among the partner K-8 schools to provide early exposure to Canton Prep as families make decisions about where to attend high school.

Mr. Batt provided a staffing update.

b. 2017 Advanced Placement (AP) Reports

The Board reviewed 2017 AP reports. Mr. Angerer answered questions from the Board about the data.

c. 2016-17 M-STEP and SAT Results

The Board reviewed 2016-17 M-STEP and SAT results. Mr. Angerer answered questions from the Board about the data. Ms. Roberts highlighted the new Monday Elective for SAT prep available to 11<sup>th</sup> graders. Mr. Batt and Ms. Roberts explained the curriculum alignment between SAT skills and M-STEP content standards. Mr. Angerer answered a question about interim assessments.

7. COMMENTS BY AUTHORIZER

Mr. Matthews updated the Board on the new GVSU Charter Schools Office director, staff retirements, and new hires – including Canton Prep’s new permanent field representative, who will be introduced at the next meeting.

8. PUBLIC COMMENT

There was no public comment.

9. BOARD COMMENTS


Mr. Angerer answered a question from the Board about the school leadership team’s focus areas for the fall term.
